

Introduction

The first five minutes of a class are among the most critical in teaching for the role they play in setting the instructional stage and transitioning students into the lesson. *Take Five Minutes: Reflective and Critical Thinking American History Class Openers* is designed to assist teachers in this task through the integration of a variety of engaging activities that not only set the stage for American history lessons but also provoke higher order thinking.

This book includes themes addressing topics from American history that span from the pre-Columbian era to the present. Each of the 72 themes includes six different types of reflective and critical thinking activities: journal writing prompts, time lines, decision-making scenarios, concept maps, Venn diagrams, and vee heuristics. (An overview of each of these activities can be found on pages 5–11.) A total of 17 activities from these six categories are included for each theme, providing students with over 1,200 opportunities to reflect upon and critically examine the major individuals, events, movements, and issues that are key to our understanding of American history.


The activities contained within *Take Five Minutes: Reflective and Critical Thinking American History Class Openers* may be used in the following manner:

- Teachers may choose to reproduce the pages containing the activities for each individual theme and distribute them to students, write them on the chalkboard/dry-erase board, or display them on a transparency or PowerPoint slide.
- Students then have the opportunity to immediately begin engaging in their daily reflective and critical thinking activity. When completed, teachers may have students turn in their work, maintain it in their student portfolio, and/or use student responses as the focus of a classroom discussion.
- Students may use their notebooks or one of the activity sheet handouts included in the book (of which two versions are provided for each of the six types of activities) to record their response to the question or task for that particular day.
- Teachers may choose to use the charts included in the book to monitor individual student progress, class progress, or as a lesson planning aid to assist in the selection of activities for each class period.
- This book is intentionally designed to give teachers the opportunity to integrate any number of these activities for each theme into their classroom curriculum. Teachers may choose to integrate only one or two of these activities if time is limited, or they can easily add more to fit their needs if time allows. In addition, teachers may elect to use these activities as pre-assessment devices to determine what students already know about a specific theme or topic in American history. Teachers may also assign the activities as homework, in preparation for classroom discussion the next day, or as an independent learning activity to be completed in class at the conclusion of a daily lesson. Finally, teachers may find these activities serve as ideal unit review questions or even as assessment items on a unit quiz or test.

The following pages (pages 5–11) contain brief summaries and completed samples of the six different types of activities included in *Take Five Minutes: Reflective and Critical Thinking American History Class Openers*.

Journal Prompts

Three journal questions are included for each of the 72 themes. These questions serve as ideal prompts or vehicles for engaging students in all levels of thinking, from the knowledge level to the evaluation level. Teachers may choose to use the full-page activity handout sheet included at the back of the book (page 158)—which allows students to delve further into a topic in order to demonstrate a deeper understanding—or the other activity sheet version (page 159) with all three journal response sections on one page—which allows for more concise responses while still serving to monitor student comprehension.


Sample Journal Prompt

Prompt: “The role of Christopher Columbus in history is greatly debated. Is his legacy positive, negative, or both? Explain.”

I think that Columbus should be remembered in history both for the good and bad that came about as a result of his voyage in 1492. His discovery of a new sea route to the new world resulted in a number of good or positive things such as the increase in trade between Europe and North and South America. Also, it led to the founding of settlements by the Spanish, and later, the English, such as St. Augustine and Jamestown. Who knows, maybe the United States would never have been created if not for Columbus. While there are good things that happened as a result of Christopher Columbus’ voyage, there were also a number of bad things. First, the conquistadors did not treat the native people with respect and often did terrible things to them such as working them as slaves and killing them in battle. Many of the native people also died as a result of the diseases that the Spanish brought over with them. Another bad thing that resulted from Columbus’ “discovery” of America was the slave trade that developed between Africa and the New World, which would last for centuries. Overall, I think that you can’t say Columbus should be remembered in history as simply a positive or negative person, instead he should be remembered as a person whose accomplishments brought about both good and bad things for the people of the world.



Time Lines

Each of the themes includes three different historical topics students can use as a focus for the construction of historical time lines. Students can use their textbooks, class notes, and other resources to assist in the design of each time line. Time-line activities are ideal for gauging student understanding of historical perspective and casual relationships. There are two different time-line handout versions included at the back of the book. The first (page 160) allows students to list a greater number of events for a given topic, as well as provide a more detailed description of each event. The other time-line handout (page 161) provides for all three topics included in each theme to be completed on a single page, allowing students to visually compare and contrast the events for each topic.

Decision-Making Scenarios

There are three decision-making scenarios provided for each theme. These scenarios allow students to demonstrate both convergent and divergent thinking skills. They also provide a way for students to participate in activities that introduce historical empathy as an instructional means for building student understanding. Teachers may elect to use either the full-page journal or notebook handout (page 162) for students to respond to these decision-making questions, or the modified version, which includes space for students to respond to all three questions for each theme on one page (page 163). In addition, there is a full-page decision-making chart (page 164) included for those teachers who desire a more structured student response to these questions.

Sample Decision-Making Scenario

Scenario: “If you were an abolitionist, would you have commended or condemned John Brown for his 1856 attack on the pro-slavery town of Pottawatomie Creek, Kansas, which resulted in the death of five settlers? Explain.”

I think if I was around in the 1850s, I would have worked hard to help bring about an end to slavery just as Frederick Douglass, Harriet Beecher Stowe, and many others did. I might have even traveled to Kansas during the debate over slavery and have worked to make sure Kansas entered the Union as a free state. The problem I have is not with what John Brown was fighting for but in the way he went about doing it. While I know that some abolitionists might have been happy when they heard the news about what happened at Pottawatomie Creek, I think many of them probably would have reacted the same way I feel, and that is it is never right for people to kill other people in cold blood just because of something they believe in. Slavery is wrong, but so is killing people, and two wrongs don't make a right. I think if I was around at this time, I would have written a letter to my local newspaper or attended an abolitionist's meeting so I could tell them how I felt. I could support a number of things the abolitionists did back then, such as writing books like *Uncle Tom's Cabin* or working on the Underground Railroad—I even would have fought in the Civil War—but I don't believe I could have supported or participated in the kind of things John Brown and his followers did at Pottawatomie Creek. The end doesn't always justify the means.







Concept Maps


A total of four key concepts—which include issues, movements, innovations, theories, and other events from American history—are included for each theme. These items serve as ideal vehicles for engaging students in concept mapping or pattern noting activities, designed to help teachers determine the breadth and depth of student knowledge and understanding. Teachers should have students write the listed concept in the center circle on the map and then expand on the concept using one- or two-word phrases to describe related characteristics (individuals, events, consequences, etc.). Students can either design a semantic concept map, placing these related characteristics in the appropriate location (circle or box); or teachers can ask students to design a structured overview concept map that also includes the listing of the verb on the stem or line that connects these items. The book includes a full-page version of a concept map (page 165) that allows for both structured overview and semantic concept mapping. There is also another version provided (pages 166 and 167) that includes two concept maps per page.




Venn Diagrams

Each theme contains two questions designed for students to respond through the use of a Venn diagram. These questions, as well as the resulting Venn diagram, are great vehicles for engaging students in analytical and convergent thinking. Teachers can instruct students in both the number of differences and similarities that should be included in their response, as well as whether students should simply list or list and describe each of these items. A full-page handout of a Venn diagram is provided at the back of the book (page 168), as well as a version that includes both Venn diagrams for each theme listed on a single page (page 169).


Sample Venn Diagram

Vee Heuristics

Two focus questions are provided for each of the 72 themes that allow students to respond through the use of a vee heuristic. With a somewhat similar format to that of a Venn diagram, a vee heuristic is designed for students to analyze dichotomous positions, policies, theories, decisions, movements, innovations, and events in American history. The vee heuristic encourages students to delve further into the dichotomous positions addressed in the focus question, because there is no provision for a comparison as there would be in a Venn diagram activity. The focus question should be listed in the center of the vee heuristic, with the two dichotomous positions labeled to the left and right of the question. A handout containing a full-page vee heuristic is provided on page 170, as well as a version that includes both of the vee heuristics for each theme on one page (page 171).

Sample Vee Heuristic

1. 1960s Civil Rights Movement

- 1960—Greensboro Sit-In movement starts
- 1961—Freedom Rides begin
- 1962—James Meredith attempts to attend the University of Mississippi
- 1963—Martin Luther King, Jr., march on Washington
- 1963—Malcolm X enters as another leader in the civil rights movement
- 1964—Civil Right Act and 1965 Voting Rights Act passed
- 1968—Martin Luther King, Jr., assassinated in Memphis
